#### **MINUTES FROM CONGREGATIONAL MEETINGS 2016**

#### **ANNUAL CONGREGATIONAL MEETING - February 21, 2016**

The annual congregational meeting of Holly Presbyterian Church of Holly, Michigan was called to order and opened with prayer by Moderator Reverend Sharlyn Gates on February 21, 2016 at 12:13 p.m. in the church sanctuary.

#### **Roll & Minutes**

Roll was taken and a quorum established with 28 active members in attendance. Minutes were approved for the following congregational meetings: February 15, 2015 and November 8, 2015.

#### Written Report Highlights

Written reports were distributed prior to the meeting. The reports were reviewed by the congregation. Here are highlights from those reports:

#### Clerk (Jim Lyles)

- Membership on December 31, 2014 was 93. There were 7 gains and 2 losses, resulting in 98 members on December 31, 2015.
- As of December 31, 2015, the membership was made up entirely of one ethnic group (Caucasian). There were 66 women and 32 men.
- 1 child was baptized in our church in 2015. There were 2 weddings.
- The Session in 2015 was made up of 10 Ruling Elders (7 female and 3 male). The session is made up of one ethnic group (Caucasian)

#### Pastor (Rev. Dr. Sharlyn DeHaven Gates)

Last January, at the Session Retreat, I asked the elders to pray – daily if possible – for Holly Presbyterian Church. Wow, what blessings we have received! We gained seven new members and continued our move toward better financial stability. We have been able to accomplish some of the big goals that were set and worked on for a while: new carpet in the Fellowship hall, a new boiler, the parking lot was redone, and the purchase of new tables. The new AV system is up and running, with skilled operators and a new station where the sound system and computers are run. This enables the use of DVDs for some contemporary worship songs along with the favorite traditional hymns. The hope is to continue this mix into the coming year. Sharlyn is grateful for the help received in many areas of ministry, by Pastor Shaun Hardimon. This includes calling on Dear Friends, hospital visits, performing a wedding Sharlyn was unable to attend to and has worked with the youth this year. Sharlyn led several retreats, a two week discussion on same-sex marriage, a four week study titled "Simplify" in the fall, and an opening presentation for our Advent program called "Prepare."

I look forward to the year 2016 with great confidence that God will continue to bless us. Please continue praying for Holly Presbyterian Church!

#### **Associate Pastor (Shaun Hardimon)**

I am grateful that I have been able to be a part of this church and working with both Rev. Dr. Sharlyn DeHaven Gates and the different teams. We have been able to accomplish work for both our community and or church. While also giving me an opportunity to gain more experience in another year of my career.

#### Activities:

- Participated in the different services during Holy Week
- Attended Team Party Nights and Session Meetings
- Performed pre-marriage counseling with Pastor Sharlyn
- Married my first couple as a pastor
- Participated in Session & Elders Retreat at Vivian's Via Rosa Retreat
- Visited church members in the hospital and in their homes
- Worked with Sara Pettit each week with the Youth Group
- Preached at Mundy Presbyterian Church
- Had conversations with people considering either CLP or seminary
- Mentoring conversation with new youth leader from Port Huron Presbytery Church
- Member of the design team for the Alma Youth Mix
- Attended Alma Youth Mix with Rachel and our church youth
- Attended the Crop Walk, Bowman Chevrolet Bake Sale, Baby Pantry and church clean-up days

#### **Treasurer (Vicki Lyles)**

Notes from December 2015 Treasurer Report (included in January's Session Meeting minutes) were used for the annual report.

#### **Christian Education (Christine Cook)**

- In 2015 we offered Adult Sunday School, Teens for Christ Sunday School, The Gathering Place, Men's Bible Study, Wednesday Lunch Bunch, Women's Bible Study and Full Church Study.
- The team hosted/co-hosted the Sunday School year-end picnic, Fall Kick-Off Sunday, and Trick or Treating at HPC.

In the fall of 2015, the Gathering Place for Kids was discontinued due to the lack of school age children currently attending. This program will be re-established when the current group of babies and toddlers reach school age.

Teens for Christ grew this year, as the previous grade school age children graduated into middle school.

A very sweet version of the Christmas Story (with puppets) was presented to the congregation by Laura Parker, assisted by Christine Cook and two of our toddlers, Abby Hardimon and Holden Pettit.

Christine is very grateful for the help from Rev. Sharlyn Gates, Pastor Shaun Hardimon, Barbara Brown, Charlee Litten, Sara Pettit, Randy Cook, Katie Whalen and Laura Parker.

#### Care (Karen Haneline)

The Care Team was very busy this year attending to the needs of the congregation. Every month, their activities included some or all of the following:

- Cards for 75 and older, anniversary cards for milestones, missing you and get well cards
- Easter and Christmas flower or greens (with assistance from the Outreach Team)
- Stephen Ministry
- Assisting Pastor Shaun Hardimon with home communions
- Keeping ministers updated so care and concerns of the congregation do not fall through the cracks
- Assist with rides to church for Dear Friends
- Visitation of Dear Friends
- Mother's Day care packages, assist Christian Ed with Fun fair, flag pins to veterans
- Helped Shaun with TFC
- Fishing poles to Camp Copneconic

#### Fellowship (Margaret Perry)

- Held three funeral dinners.
- Sponsored six bake sales, totaling \$1,400 for the boiler fund. The team plans to use bake sale proceeds to fund their budget in 2016.
- Ran coffee hour January thru May and September thru December.
- Ash Wednesday soup and bread dinner, Maundy Thursday dinner, cook out pot luck after Worship in the Park, Kick off Sunday pot luck, Snoop party, bake sale and Ambassadors reception
- Rummage sale
- Reagan Estate sale
- New refrigerator purchased

#### **Outreach (Laura Parker)**

Our congregation's ongoing ministries include:

- We continued to provide financial support for Athletes in Action Mission at the University of Michigan and the Operation Transit mission in Algeciras, Spain.
- Operating "In The Beginning Baby Pantry" mission to offer resources to families with young babies and children who are experiencing difficulties
- Assisting with the Friends with Needs social gathering for adults with mental illness
- Providing weekly meeting space for AA and Alanon groups

#### Mission Programs:

• We continued to provide financial support for Athletes in Action Mission at the University of Michigan and the Operation Transit mission in Algeciras, Spain.

The Outreach Team also oversees the church website and social media

- Website: The church website (www.hollypc.org) continues to have very good viewership. On average, there were 80 visits per day to our website, with 218 pages being viewed each day.
- Facebook pages for the church, TFC, and the Baby Pantry. Our "likes" are up 16% from last year

#### Events:

- Easter basket collection drive
- School supply collection (Holly Area Youth Assistance)
- Bake sale at John Bowman Chevrolet to raise funds for Easter baskets for Grace Centers of Hope
- Trick or Treat outreach
- Adopt-a-Family, Joy Offering, Ambassadors Concert

#### **Personnel (Charlee Litten)**

- Hired Nursery care provider, Eric Mowery, in November.
- Evaluation form revised for the pastor position.
- All personnel were evaluated; however, meetings with staff have not been completed yet.

#### **Property (Lori Goldsmith)**

- Repairs were completed for damage from broken water pipes in Gathering Place.
- Parking lot was repaired, painted and striped, with STOP banner added to main entrance.

- South boiler was replaced, new thermostats installed to prevent freezing pipes.
- Community room was deep cleaned and painted, drinking fountains were removed with drywall repaired, N/W boiler was cleaned and both boilers will now be cleaned every three years as a preventative maintenance.

#### Finance (Bob Killewald)

- Finance team met 10 times in 2015.
- An Endowment Fund has been established, which will result in increased income, moving forward.
- The 2015 Pledge Drive resulted in \$98,684 (9 new pledges and 5 increases outweighed the 7 decreases. Pledges of \$4950 for the Building Fund were received.
- The Presbytery loan balance, as of Dec. 31, 2015 was \$9,014.10.
- This year's deficit was less than half of last year's

#### **Information Technology (Walter Brown)**

- A reception desk was located and installed as an AV control console. Four operators were trained. Skype video calling has been established, making conference calling with missionaries during worship services possible.
- A new "smart" TV was installed in community room to use with DVDs, videotape, as well as connecting to a laptop for presentations and the Internet via the church's WiFi system. A back-up system has been installed on the church's computers.
- The IT Team is currently evaluating new computer programs and plans to setup and train for selected programs in February.

### **Worship (Dessalee Cook)**

- Communion was served the first Sunday of each month, Maundy Thursday, and Christmas Eve.
- Julia Belyayeva-Hull continues to direct the choir and provide our music for worship services.
- There were several special services, special music at one service, a service held at Bush Lake Park in July, an Ash Wednesday service, and a candlelight Christmas Eve service.

#### **Teens for Christ (Sara Pettit)**

A new rotation model was put in place, relating around fun, outreach, and religious study.

- Teens for Christ (TFC) participated in the Alma Youth Mix in March.
- Outreach projects include: making wood flowers and Christmas trees for "Dear One's" and working at the Eastern Food Bank.

#### In the Beginning Baby Pantry (Laura Parker)

- · We have assisted 79 families this year
- 31 families are now retired (no longer need support) making a total of 84 retired families.
- 164 families have been helped since the Baby Pantry was established 4 years ago.
- The Baby Pantry is supported by our congregation, people outside the congregation, other area churches, businesses and private donors

#### Friends with Needs (Laura Parker and Judy Wood)

- This year it has become apparent that this group needed support in order to function well, as well as the use of the community room in our church. They are well funded by fundraisers they do themselves and outside donors, to cover the increased heating and water costs to the church.
- They enjoy sharing stories, playing games and holding a weekly bible study. They pray for out church and have great appreciation for our hospitality.

#### **Presbyterian Women (Laura Parker)**

Our group is currently inactive, but use the annual PW Bible Study.

- In June, 4 members attended the tri-annual Gathering of Presbyterian Women in Minneapolis. Three were scholarship recipients from the PW of the Lake Huron Presbytery.
- Our church hosted the PW Fall Gathering in October and received donations for the Baby Pantry and the table and chair fund.
- We hope to organize our women's group in the coming year.

#### **Terms of Calls**

Rev. Gates temporarily turned the meeting over to Finance Chair Bob Killewald and left the room during the discussion and vote for her terms of call.

A motion to approve the terms of call, as listed in the distributed reports and also to be listed in the minutes for the February 16, 2016 stated session meeting, was sustained unanimously by voice vote.

Rev. Gates was informed of the vote results and returned to the meeting.

There being no further business, Reverend Sharlyn Gates closed the meeting with prayer at 12:48 p.m.

# **Treasurer's Report for 2016**

Treasurer's Notes - December, 2016

On the Profit and Loss Budget vs. Actual report, the percentages in the right hand column should be 100%. It is good if income accounts have percentages higher than this and if expense accounts show lower percentages.

Sunday giving was 63.3% of the adjusted budgeted amount for the month, with pledged income at 86.8%. As last year, non-pledged income was significantly lower in December than it has been in the past.

You do not see a loan payment to Presbytery in December because I do not have a new amortization schedule to be able to assign the interest and principal (the interest rate changes each year). The payment was written in January, and paid on time.

The final payment for the women's restroom was made. I have not yet seen a bill for more tile and matching vanity for the men's restroom (purchase approved by session previously).

Three of the accounts listed on the Balance Sheet are investment accounts (not bank accounts). The amount listed on the Balance Sheet does not generally change, unless we send money to them for investment. This is because they can, and do, go up and down monthly, and including those market changes in the report will only make it more complicated to interpret. However, now that they are all funded, it is appropriate to look at their balances periodically. So I will list them at the end of each year.

HPC Endowment Fund: \$1,528.82 HPC Investment Fund: \$22,957.20 NFS: \$23,064.38

A few notes about these funds: the HPC Endowment Fund was created for long term investments. Only the income created is accessible to be spent. This year, we added \$1200 to this fund (a portion of the proceeds from the Wright trust). The HPC Investment Fund will provide income to the church, but the original investment is available for a major need. NFS contains the remaining Regan scholarship money, the music fund money (for use by the choir), and \$4000 of money received from the Wright trust several years ago.

# **Information Technology Team Report for 2016**

The Information Technology (IT) Team is responsible for all installation and maintenance of the church's electronic equipment, including the phone system, computers and computer systems, audio/visual equipment, and monitoring of the AT&T file server used for the church's Website. Team members include: Jim Lyles, Brian Parker, Sara Pettit and Walter Brown.

#### Overview of 2016 calendar year projects:

- The team decided to keep all computers (the office computer, Pastor's study computer, financial laptop and A/V computer) equipped with Windows 7, rather than upgrading to Windows 10. Some of the computers are too old and/or have not enough RAM, and it was decided to keep all the computers on the same operating system. Microsoft will continue supporting Windows 7 until January 2020.
- Norton Security Deluxe (antivirus) software was installed on the office computer, Pastor's study computer, financial laptop, and A/V computer.
- The wiring for the Community Room phone was moved to a higher location on the wall, to allow the Property Team to reposition the cabinets.
- A WIFI router was added in the Gathering Place area to extend wireless access to the west side of the church, including the sanctuary, narthex, and the Gathering Place.
- A second WIFI router was added in the Associate Pastor's study, to ensure reliable wireless access on the east side of the church.
- Micha Webner evaluated the sanctuary's audio system and determined that different cables and adapters were needed. These were ordered and installed.
- A new phone system was purchased and installed at the church.
- The church was switched to a new (and somewhat cheaper) internet & phone service provider. All computers and network printers were reconfigured to work correctly on the new service.

#### Planned 2017 Projects:

- The IT Team will be working on purchasing or leasing a new copier for the office.
- The IT Team will consider the purchase of a new publishing software to use for many printing needs including bulletins, newsletters, special publications, etc. We will revisit a LucidPress subscription. The cost is \$480 per year, which includes licenses for five computers. The cloud-based software -- with multiple licenses -will allow real-time collaboration between multiple users.
- The IT team will be looking at options for recording sermons and distributing them on the internet.
- The IT team will work on establishing a system for sharing documents online (for example, Google Docs).
