# Session Highlights from November 17, 2021

• Charlee Litten contacted several janitorial services. There are two who will be meeting for a walk-through at church this week. Both are licensed and bonded. Other options are also being considered. A new part-time janitorial job description was also approved. Volunteers will be sought to take turns cleaning the church every two weeks, until we have a new janitorial service.

• Session discussed options in the event that Rev. Brooke and/or any immediate family member either have been exposed to or contracted COVID-19. There is a recent concern that Mather was exposed and may have contracted the virus. Several ideas were discussed. At the present time, it was decided that Brooke would record her sermon and have a printed copy also available. The recorded sermon could be played on the church's Audio/Visual system, or one of the elders could read the sermon. Jim Lyles will either lead the service or find someone to lead the service on Sunday, November 21, if Brooke is unable to.

• A motion to approve spending up to \$500 to buy HEPA UV air purifiers for the office and Pastor's Study was sustained.

• The Finance team is working on the 2022 budget.

• IT has determined that the five church computers cannot be upgraded to Windows 11. All are currently running Windows 10. Support for Windows 10 will end in Oct. 2025. The team will develop a plan for replacing these computers over the next four years.

• Holly Area Youth Assistance has contacted the church. They have a family for us to support for Christmas.

- More work was done on the front landscaping with new plantings.
- Four HEPA UV air purifiers were purchased and installed in the Sanctuary.

• Railings were installed on the new concrete staircase going down to the office exterior entrance. Work is still proceeding on the railing repairs for the new back porch steps and the front porch steps.

• Irish Brothers was contracted to handle snow and ice removal for this winter.

We will ask for small groups of people to put up Christmas decorations at various times instead of gathering everyone together after worship service.
Christmas Eve worship service will be at 6:30 p.m. LED candles will be used instead of real candles.

# TREASURER Your Donations and Taxes

If you have been donating to the church online, those donations will NOT be on your annual giving statement from HPC. They cannot be counted twice, and have already been acknowledged by the company who processes them.

If you are able to itemize on your income taxes, your last donation for the year must be handled in one of two ways:

- 1. By mail, be postmarked by December 31, 2021.
- 2. In person, must be delivered to the church by December 31, 2021.

If you come to church on Sunday, January 2, 2022 and place a 2021 check or offering envelope in the collection plate, we cannot legally count it (for tax purposes) as a 2021 charitable contribution. If you have any questions, please see me (I will not be at worship on December 26; we will be visiting family).

From the Lion's Den- November 17th

Anne Lamott is one of the most popular Christian writers today. Her best-seller, Traveling Mercies: Some Thoughts on Faith, told her story of her coming to faith and discovery of grace in a community of those on the margins of the church. A recent book of hers is Help, Thanks, Wow, which addresses the three essential attitudes of prayer.

In this season of Thanksgiving, I turned to Anne Lamott for inspiration. In the section on "Thanks," she writes, "Gratitude begins in our hearts and then dovetails into behavior. It almost always makes you willing to be of service, which is where the joy resides. It means you are willing to stop being such a jerk. When you are aware of all that has been given to you, in your lifetime and in the past few days, it is hard not to be humbled, and pleased to give back." (New York: Riverhead, 2012, 56-57).

She adds, "Saying and meaning 'Thanks' leads to a crazy thought: What more can I give? We take the action first, by giving – and then the insight follows, that this fills us... It obviously behooves me to practice being receptive, open for the business of gratitude." (62)

"A nun I know once told me she kept begging God to take her character defects away from her. After years of this prayer, God finally got back to her: I'm not going to take anything away from you. You have to give it to Me." (63)

Gratitude is a response to grace that leads to action. How can we express our thanks to God for all God has given to us? What are we going to give to others? What are we going to give back to God – both of our possessions and of our vices?

Our December Presbytery meeting will focus on the theme of how congregations can respond to food insecurity in their communities. Julianne Princinsky, who is Chair of the Board of the Food Bank of Eastern Michigan and an elder at St. Andrew's Presbyterian Church in Davison, will offer the message and lead a panel discussion of leaders whose churches are making a difference to address food insecurity in their communities.

As we share our Thanksgiving feasts with family and friends, let us also consider how we might share our abundance – and ourselves – with those most in need.


